ARTICLES OF INCORPORATION OF ROCK-N-ROLL,COM, INC.

The undersigned subscriber(s) to these Articles of Incorporation, natural person(s) competent to contract, hereby form a corporation under the laws of the State of Florida.

ARTICLE I – CORPORATE NAME

The name of the corporation is: Rock-N-Roll.Com, Inc.

ARTICLE II - DURATION

This corporation shall exist perpetually unless dissolved according to Florida Law!

ARTICLE III - PURPOSE

The Corporation is organized for the purpose of engaging in any activities or business permitted under the laws of the United States and the State of Florida.

ARTICLE IV - CAPITAL STOCK
