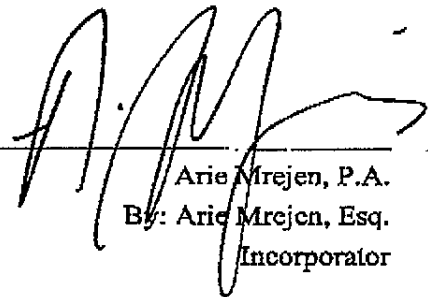
ARTICLE XI: INDEMNIFICATION

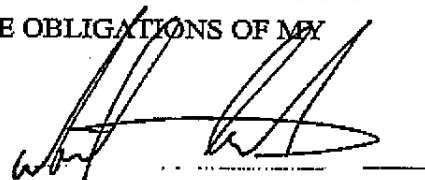
