ARTICLE I. NAME

The name of this corporation is ORNAMENTAL PLANTS IMPORTS, INC.

ARTICLE II. DURATION

This corporation shall begin its existence on the 10<sup>th</sup> day of October, 2000.

This corporation is organized for the purpose of engaging in any activity or business permitted under the laws of the United States and the State of Florida.
