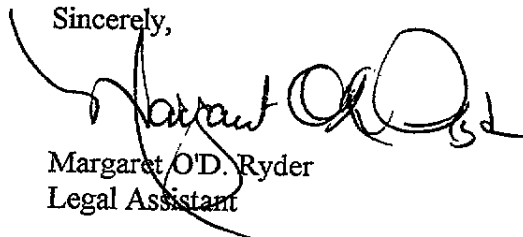

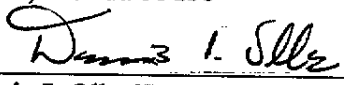
**ARTICLE VI - INITIAL BOARD OF DIRECTORS**

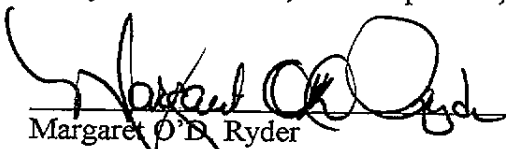
