CORPORATE NAME

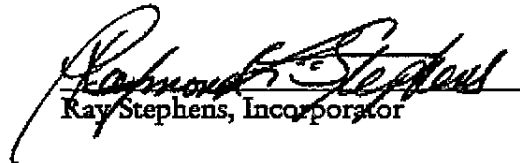
AMENDMENTS AND BYLAWS
