



ARTICLES OF INCORPORATION

OF

MANNY DE CASO, INC.

ARTICLE I

The name of this corporation is MANNY DE CASO, INC., whose principal address is 12271 S.W. 46th Street Miami, Florida 33175

ARTICLE II

The general nature of the business to be transacted by this corporation is to engage in Vehicle Export, a business permitted under the laws of the State of Florida.

ARTICLE III

The maximum number of shares of stock that this Corporation is authorized to issue and have outstanding at any one time is ONE THOUSAND (1,000) shares of common stock having a par value of ONE DOLLAR (\$1.00) per share.


