SECOND: The foregoing amendment to the Articles of Incorporation of PRITTS & ASSOCIATES, INC., was adopted as of September 17, 2004.

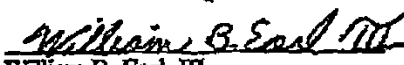
THIRD: The amendment was approved by the officers and shareholders of the corporation. The number of votes cast for the amendments was sufficient for approval.
