The name of the corporation shall be: **DISCONNECTED MUSIC, INC.**

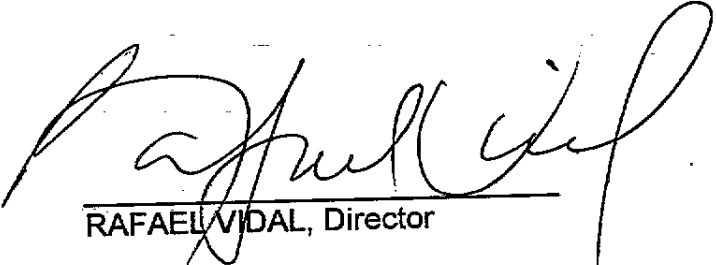
