**ARTICLES OF AMENDMENT TO THE
ARTICLES OF INCORPORATION OF JOAN OHOMES, INC.
CHANGING THE NAME TO JOAN C. OLISZEWSKI, P.A. AND AMENDING
ARTICLE II- THE NATURE OF THE BUSINESS OF THE CORPORATION**

Pursuant to the provisions of Sections 607.1006, Florida Statutes, the undersigned corporation submits the following articles of amendment.

1. ARTICLE I is amended as following to change the name of the corporation to "JOAN C. OLISZEWSKI, P.A." as follows:

"ARTICLE I - NAME

The name of this corporation is JOAN C. OLISZEWSKI, P.A."

2. ARTICLE II – NATURE OF BUSINESS is amend as follows:

"ARTICLE II - NATURE OF BUSINESS

The general nature of the business to be conducted and created by this corporation is:

1. To invest in or engage in the practice of real estate and to provide professional service to the public of those services authorized pursuant to Chapter 475 of the Florida Statutes.
2. To own property, enter into contracts and to carry on any business necessary or incidental to the accomplishment or furtherance of the purposes and objectives of this corporation.
3. To do all and everything necessary and proper for the accomplishment of the objects enumerated in these Articles of Incorporation, or any amendment thereof, or necessary or incidental to the protection and benefit of the Corporation, and in general to carry on any lawful business necessary to, or incidental to, the attainment of the objects of the Corporation, whether or not such business is similar in nature to the objects enumerated in these Articles of Incorporation, or any amendment thereof.
4. The professional services of this corporation shall be carried out only through officers and agents, each of whom, shall be duly licensed to perform such services.

The foregoing clauses shall be construed both as objects and as powers, and it is hereby expressly provided that the foregoing enumeration of powers shall not be held

to limit or restrict in any manner the powers of the Corporation, and each power and object shall be construed as if named separately and alone, and shall not be limited in any way because of the naming of any other power or object."

3. The amendment shall become effective on the date of filing with the Secretary of State of the State of Florida. The date of Adoption for this amendment is December 27, 2005.

4. The foregoing amended was adopted at a meeting called by the Corporation in accordance with the Articles of Incorporation and By-Laws of the Corporation and approved by the sole Stockholder of the Corporation and all of the Officers and Directors of the Corporation.
