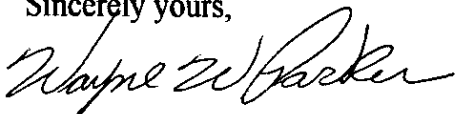
This letter is in response to the letter received from RoseAnn Varnadore, Document Specialist Supervisor, Division of Corporations, October 8, 2002.
