The effective date of this corporation is the date of filing by the Secretary of State, Florida.

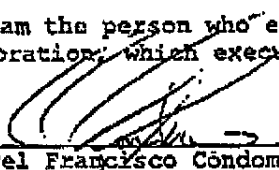
