**ARTICLES OF INCORPORATION
OF

ARTICLE ONE

The name of the corporation is SOCCER PEREA FC, INC.

ARTICLE TWO

The term of existence of the corporation shall commence upon its being filed with the Secretary of State of Florida and is perpetual.

ARTICLE THREE

The purpose for which the corporation is organized is to engage in any activity allowed or authorized by the laws of the State of Florida .

ARTICLE FOUR




