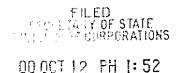

Directors of this corporation need not be residents of the State of Florida, unless otherwise provided in the Articles or Bylaws of the Corporation.

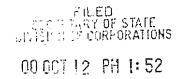
The shareholders of this Corporation shall have exclusive authority to fix compensation of the directors of this corporation, unless otherwise provided in the Articles or Bylaws.
