

## **ARTICLES OF INCORPORATION**

The undersigned Incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

### **ARTICLE I-NAME**

The name of the corporation shall be AERRAGREEN OF WEST FLORIDA, INC.

### **ARTICLE II-PRINCIPAL OFFICE**
