ARTICLES OF INCORPORATION

The undersigned, being of the age of eighteen years or more, does hereby make and acknowledge the Articles of Incorporation for the purpose of forming a business corporation under and by virtue of the laws of the State of Florida in accordance with the Florida General Corporation Act.

ARTICLE I

The name of the corporation is TRISTA, INC.

ARTICLE II

The period of duration of the corporation shall be perpetual.

ARTICLE III

The purpose for which the corporation is organized is to engage in any lawful act or activity for which corporations may be organized under the Florida General Corporation Act.

ARTICLE IV

The corporation shall have authority to issue seven thousand five hundred (7,500) shares of common stock having a par value of One Dollar (\$1.00) per share.

ARTICLE V

Every shareholder shall have a preemptive right to acquire pro-rata additional shares when issued or authorized, including treasury shares.

ARTICLE VI

The address of the initial registered office of the corporation in the State of Florida is 147 Park Drive, Satsuma, Putnam County, Florida 32189; and the name of its initial registered agent at such address is F. E. Herman. The principal office of the corporation and the office of the Registered Agent are both located at 147 Park Drive, Satsuma, Putnam County, Florida 32189

ARTICLE VII

The number of Directors constituting the initial Board of Directors shall be two
(2). The numbers of Directors may be increased or decreased from time to time in accordance with the By-Laws adopted by its shareholders, but the number of Directors shall never be less than one (1). The names and addresses of the persons who are to serve as Directors until the first meeting of its shareholders, or until their successors be elected and qualified, are:

ARTICLE IX


