ARTICLES OF INCORPORATION
OF

The undersigned, being a natural person, does hereby act as Incorporator in adopting the following Articles of Incorporation for the purpose of organizing a business corporation pursuant to the provisions of the Florida General Corporation Act.

Article I

The name of the Corporation (hereinafter called the "Corporation") is **Feeder Fix, Inc.**

Article II

The address of the principal office of the Corporation is 9090D Southwest 21st Street, Boca Raton, Florida, 33428.

Article III

The purpose or purposes for which the Corporation is organized is to transact all lawful business for which Corporations may be organized under the Business Corporation Act of Florida.

Article IV

The corporate existence of the Corporation shall commence upon the filing of these Articles of Incorporation with the Department of State, State of Florida.

Article V

The term of existence of the Corporation shall be perpetual.

Article VI

The aggregate number of shares which the Corporation shall have authority to issue is ten thousand (10,000), all of which shall have a par value of One Dollar (\$1.00) and are the same class and are to be common shares.

Article VII

The initial Board shall consist of two (2) Directors and the names and addresses of the persons who shall serve as Directors until the first annual meeting of Stockholders or until their successors can be elected and qualified are:

The Corporation shall, to the fullest extent permitted by the provisions of the Florida General Corporation Act, as the same may be amended and supplemented, and in a manner provided for in the By-Laws, indemnify any and all persons whom it shall have power to indemnify under said provision.

The Corporation reserves the right to amend or repeal any provision in these Articles of Incorporation in the manner provided by law.




