**ARTICLES OF INCORPORATION
OF

ARTICLE I - NAME AND PRINCIPAL ADDRESS

ARTICLE II - REGISTERED OFFICE AND AGENT

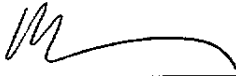
ARTICLE VI - AMENDMENTS
