

# ARTICLES OF INCORPORATION OF PRIESTER TRUCKING INC.



I, David R. Priester Jr., do hereby express my intentions to form a corporation LURI under the laws of the State of Florida, by and through those provisions of the statutes of the State of Florida providing for the foundation, liabilities, rights, privileges and immunities of a corporation for profit.

#### ARTICLE I
