ARTICLES OF INCORPORATION
OF
CONCRETE PUMPING SERVICE CORP

WE, the undersigned, hereby associate ourselves together for the purpose of becoming a corporation under the laws of the State of Florida, by and under the provisions of the Statutes of the State of Florida, providing for the formation, liability, rights, privileges and immunities of a corporation for profit.

ARTICLE I

NAME

CAPITAL STOCK

The total number of shares of capital stock which may be issued by this corporation is seven thousand five hundred (7,500) shares of par value of one dollar (\$1.00) per share, all of

which shall be common stock and shall be fully paid and non-assessable. All such stock shall be payable in cash, property, labor or services at a just valuation to be fixed by the Board of Directors at a meeting called for that purpose.

ARTICLE IV

AMOUNT OF CAPITAL TO BEGIN BUSINESS WITH

voidable because one or more of the Directors or officers or stockholders of the corporation, is or are interested in such contract or transaction as a Director or officer or stockholder of the other corporation, or association or otherwise individually or jointly a party to any such contract or transaction with this corporation, or in which this corporation is interested; and no Director or officer of this corporation shall incur any liability by reason of the fact he is or may be interested in any such contract or transaction. A Director of the corporation may vote upon any such contract or other transaction between the corporation and any officer, Director or stockholder thereof or any corporation, association, person or firm in which such officers, Directors or stockholders are interested, including the Director creating such vote.
