THE UNDERSIGNED SUBSCRIBERS TO THESE ARTICLES OF INCORPORATION, EACH A NATURAL PERSON, COMPETENT TO CONTRACT, HEREBY ASSOCIATE THEMSELVES TOGETHER, TO FORM A CORPORATION FOR PROFIT, UNDER THE LAWS OF THE STATE OF FLORIDA.

ARTICLE I

THE CORPORATION WILL BE NAMED ACES MOVING CO., INC., HAVING BOTH ITS PRINCIPAL ADDRESS AND MAILING ADDRESS LOCATED AT 7402 YACHTSMAN DR., HUDSON, FL 34667.

ARTICLE II

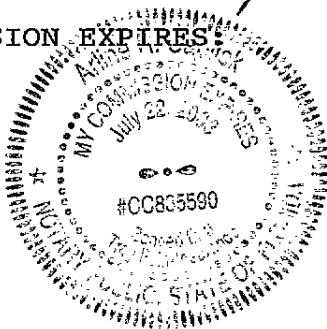
