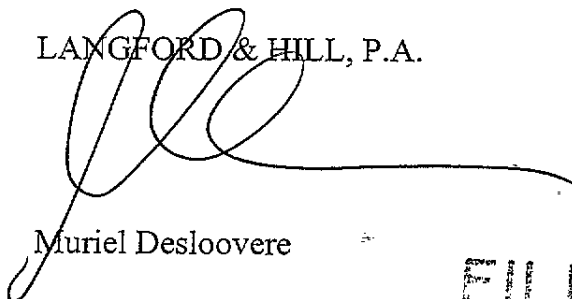

The undersigned, for the purpose of forming a Corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation.

**Article I - Name**

The name of this Corporation is RUMBLE CITY PRODUCTIONS, INC. The mailing address of this Corporation shall be 3105 West Azeele Street, Tampa, Florida 33609, or such other address as may be designated by the Board of Directors.

**Article II - Capital Stock**

The Corporation shall have the authority to issue 10,000 shares of common stock, par value \$0.01 per share.

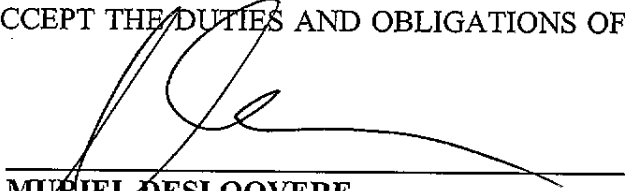
