
I am in receipt of your letter REF: P00000096886.

I know we were late in filing, however, I ask that you show us some clemency. We lost our entire office in the 2 hurricanes of 2004. Our office was upstairs in an older building in Jupiter, FL (where the two hurricanes came in within ½ mile of each other). The roof collapsed into our offices. We had boarded up the windows and never expected the roof to go. We lost all of our files, desks, furniture and computers. Everything! We thought we had contents insurance, but found out that the new bookkeeper had not paid the insurance back in April.

We ran 3 businesses from this office and have had a very difficult time trying to rebuild our businesses. We moved what little could be salvaged to our home and ran the business there until phones were installed at our new office location in Palm City towards the end of November. The paperwork end of the business has been irretrievably lost, causing immense confusion and delays. We have suffered a 100% staff turn over, three times, since the hurricanes. It has been a challenge to find persons to work, who can deal with the challenge of jobs in progress and no paperwork.

It is not my intention to burden you with my business problems but to appeal to you, based on the extreme circumstances we have been through, to grant clemency on this late filing fee.
