ARTICLES OF CORPORATION LONG INVESTMENTS AND DEVELOPMENT CORPORATION

ARTICLE ONE NAME

The name of the corporation is Long Investments and Development Corporation.

ARTICLE TWO

Corporation's Principal Office Address, 1712 N.E. Waldo Road, Suite B, Gainesville, County of Alachua, State of Florida, 32609.

ARTICLE THREE DURATION

The duration of the corporation shall be perpetual.

ARTICLE FOUR PURPOSE

The nature of the business, or objects or purposes proposed to be transacted, promoted or carried on are:

To purchase, receive by way of gift, subscribe for, invest in, and in all other ways acquire, invest, lease, possess, maintain, handle on consignment own hold for investment or otherwise use enjoy, exercise, operate, manage, conduct, perform, make, borrow guarantee, contract in respect of, trade and deal in, sell, exchange, let, lend, export, mortgage, pledge, deed in trust, hypothecate, encumber, transfer, assign, and in all other ways dispose of, design, develop, invent, improve, equip, repair, alter, fabricate, assemble, build, construct, operate, manufacture, plant, cultivate, produce, market, and in all other ways (whether like or unlike the foregoing), deal in and with property of every kind and character, real, personal or mixed, tangible and intangible, wherever situated and however held including but not limited to, money, credits, securities, stocks, bonds, warrants, scripts, certificates, debentures, mortgages, notes, commercial paper and other obligations and evidences of interest in or indebtedness of any person, firm or corporation, foreign or domestic, or of any government or subdivision or agency thereof, documents of title, and accompanying rights, and every other kind and character of personal property (improved and unimproved), and the products and avails thereof, and every character of interest therein and appurtenance therein and appurtenance thereto, including, but not limited to, mineral, oil, gas, and water rights. All or any part of any going business and its incidents, franchises, subsidiaries, charters, concessions, grants, rights, powers or privileges, granted or conferred by any government or subdivision of agency, thereof, and any interest in or part of any of the foregoing, and to exercise in respect therof all of the rights, powers, privileges, and immunities of individual owners or holders thereof;

To hire and employ agents, servants and employees, and to enter into agreements of employment and collective bargaining agreements, and to act as agent, contractor, trustee, factor or otherwise, either alone or in company with others;

To promote or aid in any manner, financially or otherwise, any person, firm, association or corporation, and to guarantee contracts and other obligations;

To let concessions to others to any of the things that this corporation in empowered to do, and to enter into enter into, make, perform and carry out, contracts and arrangements of every kind and character with and Government or authority of subdivision or agency thereof;

In general, to engage in any other activity or to carry on any other business in connection with the foregoing within the purposes for which corporations may be organized under the Florida General Corporation Act, and to do any or all of the things set forth herein to the same as natural persons might or could do.

The foregoing statement of purposes shall be construed as a statement of both purposes and powers, shall be liberally construed in aid of the corporation, and the powers and purposes stated in each clause shall, except where otherwise stated, be in no wise limited or restricted by any term or provision of any other clause, and shall be regarded not only as independent purposes, but the purposes and powers stated shall be construed distributively as each object, expresses, and the enumeration as to specific powers, but are in furtherance of, in addition to and not in limitation of said general powers.

ARTICLE FIVE CAPITALIZATION

The corporation shall issue two (2) classes of stock, voting and non-voting. The aggregate number of shares of voting common stock which the corporation shall have the authority to issue shall be one thousand (1,000) shares at a par value of one dollar (\$1) per share. The aggregate number of shares of non-voting common stock which the corporation shall have the authority to issue shall be one thousand (1,000) shares at a par value of one dollar (\$1) per share. At any time and from time to time when authorized by resolution of the board Directors and without any action by stockholders, the corporation may issue or sell any shares of its capital stock, whether out of the unissued shares thereof authorized by the Articles of Incorporation of the corporation as originally filed or by any amendment thereof.

The corporation may receive in payment, in whole or in part, for any shares of its stock issued or sold by it, cash, labor done, personal or real property, or leases thereof, and in the absence of actual fraud in the transaction, the judgement of the directors of the corporation as the value of the labor, property, real estate, or lease thereof so received, shall be conclusive.

ARTICLE SIX REGISTERED OFFICE AND REGISTERED AGENT

ARTICLE NINE PREEMPTIVE RIGHTS

When the Board of Directors so determine, the increased stock provided for by these Articles of Incorporation, and any further increase of the same, or any portion thereof, shall first be offered, a price determined by the Board of Directors, pro rata to the stockholders of record who may desire to subscribe for such stock.

ARTICLE TEN BOARD OF DIRECTORS

The business of the corporation shall be managed and conducted by a board of not more than two (2) directors. The Board of directors shall be elected in the manner set forth in the bylaws. In addition to the powers and authority granted to the directors in these Articles of Incorporation, and in addition to the powers and authority expressly conferred on them by statute, the Board of directors of the corporation shall have additional powers and authority, not inconsistent with law, as may be set forth in the bylaws.

ARTICLE ELEVEN AMENDMENT

The corporation reserves the right to amend, add to, or repeal any provision contained in these Articles of Incorporation, in the manner consistent with law and in conformity with the provisions set forth on the bylaws.
