1. Roger Futerman is the Director of ROGER FUTERMAN, P.A., a Florida professional corporation, (hereinafter "Corporation").
2. That the Corporation was administratively dissolved by the Florida Department of State on October 1, 2004.
3. That the Corporation failed to file its 2004, 2005, and 2006 Annual Report or pay the 2004, 2005, and 2006 Annual Report filing fee within the time prescribed by Florida Statutes Chapter 607 because:
  - 3.1 the written notice and requirements for filing the Annual Report and pay the Annual Report fee to the Florida Department of State was never received by the Corporation; and,

6. No further ground or grounds exist for the administrative dissolution of the Corporation.


