We, the undersigned, do hereby subscribe to these Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida, Chapter 607.0401 and subject to the following provisions:

ARTICLE I - NAME

The name of the Corporation shall be SIDE STREET WEAR, INC.

ARTICLE II - NATURE OF BUSINESS

This corporation may engage in any activity or business permitted under the laws of the United States and of the state of Florida.

ARTICLE III - CAPITAL STOCK

The maximum number of shares of stock which the Corporation shall have outstanding at any time shall be one-thousand (1000) shares of common stock, having a \$0.01 par value per share.

ARTICLE IV - CORPORATE OFFICE

The principal office of the corporation shall be located at 224 Eighth Street, Miami Beach, Florida 33139.

Other offices for the transaction of business may be located wherever the Directors may deem necessary or expedient.

ARTICLE V - BOARD OF DIRECTORS

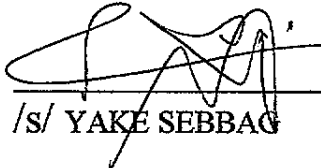

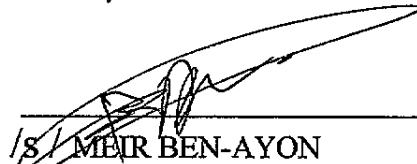

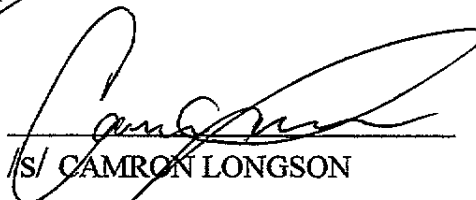
## ARTICLE VIII - TERM OF EXISTENCE

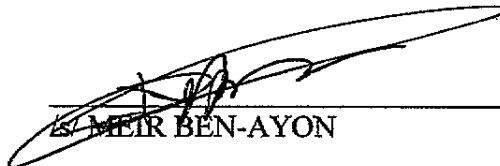
