THE UNDERSIGNED SUBSCRIBER to these
Articles of Incorporation, a natural person competent
to contract, hereby forms a corporation for profit
under the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation is:

A FINE REPORTING COMPANY, INC.

ARTICLE II - NATURE OF BUSINESS

This corporation may engage in any
activity or business permitted under the laws of the
State of Florida and of the United States.

ARTICLE III - CAPITAL STOCK

The maximum number of shares of stock that
this corporation is authorized to have outstanding at
any one time is five hundred (500) shares of common
stock, each share having a par value of One Dollar

(\$1.00) per share. The consideration to be paid for each share shall be fixed by the Board of Directors from time to time.

ARTICLE IV - PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro-rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

ARTICLE V - TERM OF EXISTENCE

This corporation shall have perpetual existence.

ARTICLE VI - ADDRESS

The initial street address of the principal office of this corporation is to be at:

The Board of Directors may, from time to time, move the principal office to any other address in Florida.

ARTICLE VII - DIRECTORS

This corporation shall have one (1) Director initially. The number of Directors may be increased and decreased from time to time by the by-laws adopted by the shareholders, but shall never be less than one (1).

This corporation shall qualify under Section 1244 of the Internal Revenue Code and Regulations issued thereunder, and the plan to issue Section 1244 stock shall be adopted by the Board of Directors.

ARTICLE XIV - LIABILITY

Neither the shareholders, directors, officers, or agents of said corporation shall be

personally liable for debts or obligations of the corporation.


