The undersigned natural persons acting as Incorporator of a Corporation under the provisions of the Florida General Corporation Act, hereby adopts the following ARTICLES OF INCORPORATION:

ARTICLE I
Name and address of the Corporation

Duration

The period of duration of the Corporation is: Perpetual.

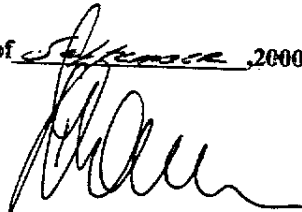
