ARTICLES OF INCORPORATION OF ANIMAL EYE CENTER OF DESTIN, INC.

FILED 00 OCT 16 AM 10: 30

The undersigned, desiring to form a professional service corporation under Chapter 607, the Florida General Corporation Act, and Chapter 621, the Professional Service Corporation Act, does hereby certify:

ARTICLE 1.

The name of this corporation (which is hereinafter called the "Corporation") shall be Animal Eye Center of Destin, Inc.

ARTICLE 2.

The purposes for which the Corporation is formed are:

- (a) To engage in every aspect of the practice veterinarian ophthalmology and veterinarian medicine.
- (b) To engage in and render professional services only through its officers, agents and employees who shall be duly licensed and authorized within the State of Florida to practice"profession", and to engage in no other business other than the rendition of such professional services.
- (c) To invest its funds in real estate, mortgages, stocks, bonds and any other type of investments, and to own real and personal property.
- (d) To do everything necessary and proper in accomplishing the purposes herein set forth and to do anything incidental thereto, as permitted under the laws of the State of Florida.

ARTICLE 3.

The Corporation shall have perpetual existence.

The shareholders may amend the Articles of Incorporation without an act of the Directors, and all of the Directors and all of the shareholders eligible to vote may sign a written statement manifesting their intention that an amendment to the Articles of Incorporation be adopted.
