## ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

### ARTICLE I - Name

The name of the corporation is DAVIS INSURANCE SERVICES, INC.

## **ARTICLE II - Duration**

The period of duration of the corporation is perpetual.
