**ARTICLES OF INCORPORATION





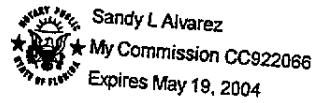
