Article I - Name



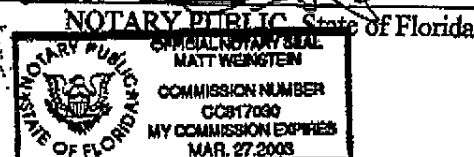

