ARTICLES OF INCORPORATION

OF

A Professional Service Corporation



The undersigned, being duly licensed in the State of Florida as attorneys, and desiring to form a corporation under the Florida Professional Service Corporation Act for the practice of law, do hereby adopt the following Articles of Incorporation:

ARTICLE ONE

NAME AND PRINCIPAL OFFICE

The name of the corporation is:

ARTICLE TWO

DURATION

This corporation shall have perpetual existence, commencing upon the date of execution and acknowledgment of these Articles of Incorporation.

ARTICLE THREE

PURPOSE

This corporation is organized for the sole and specific purpose of practicing law, and the corporation shall not engage in any other business. Provided, however, that nothing herein contained shall be interpreted to prevent the corporation from investing its funds in real estate, mortgages, stocks, bonds, or any other type of investments, or from owning real or personal property necessary for the rendering of professional services in the field of law.

ARTICLE FOUR

CAPITAL STOCK - LIMITATIONS

This corporation is authorized to issue 1,000 shares of ONE DOLLAR (\$1.00) par value common

stock. The corporation shall not issue any of its capital stock to anyone other than an individual who is duly licensed or otherwise legally authorized to render professional services in the field of law. No shareholder of the corporation shall sell or transfer any of his or her shares in the corporation except to another individual who is eligible to be a shareholder of this corporation. No shareholder of the corporation shall enter into a voting trust agreement or any other type agreement vesting another person with the authority to exercise the voting power of any or all of his or her stock. Nothing contained herein shall be interpreted to require that the right of an individual to be a shareholder of the corporation is dependent upon the present or future existence of an employment relationship between him or her and the corporation, or his or her present or future active participation in any capacity in the production of income of the corporation or in the performance of the services rendered by the corporation.

ARTICLE FIVE

RENDITION OF SERVICES - LIMITATIONS

The corporation shall render professional services only through its officers, employees and agents who are duly licensed or otherwise legally authorized to render such professional services within this State; provided, however that this provision shall not be interpreted to include in the term "employee", as used herein, clerks, secretaries, bookkeepers, paralegals, and other assistants who are not usually and ordinarily considered by custom and practice to be rendering professional services to the public for which a license or other legal authorization is required. If any officer, shareholder, agent or employee of the corporation who has been rendering professional services to the public becomes legally disqualified to render such professional services within this State or accepts employment that, pursuant to existing law, places restrictions or limitations upon his or her continued rendering of such professional services, he or she shall sever all employment with, and financial interests in, the corporation forthwith.


