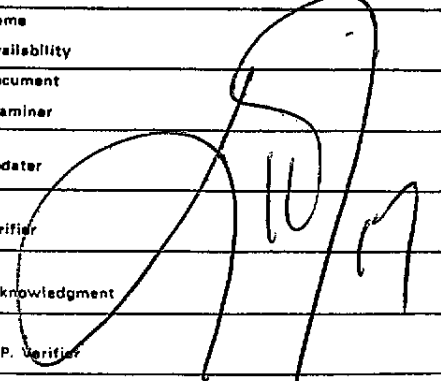

ARTICLE ONE

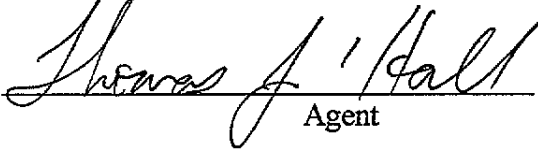
