ARTICLES OF INCORPORATION

OF

TULSI, INC.

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following articles of incorporation for such corporation:

ARTICLE I. NAME AND ADDRESS: The name and address of the corporation is: TULSI, INC., 342 South Atlantic Avenue, Ormond Beach, Florida 32176.


