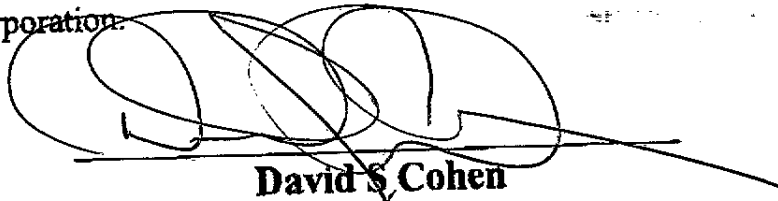
ARTICLE V
