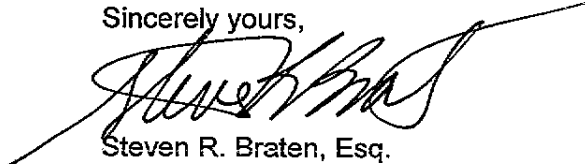

The undersigned subscriber hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

**ARTICLE VI. OFFICERS AND DIRECTORS**

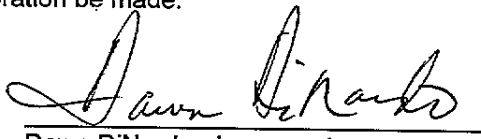

ARTICLE VIII. AMENDMENTS

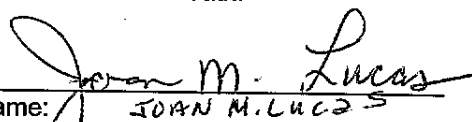
