ARTICLES OF INCORPORATION
OF

ARTICLE I

The name of this corporation is OSLEC LAWN CARE & LANDSCAPING, INC.


ARTICLE X

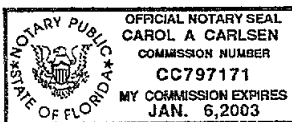
