As per today's conversation, my intentions are to clarify all misinterpretations and lost information for our annual uniform business report.

1. On June 15, 2001 we received correspondence that we had until may 2001 to pay for our uniform report fee (\$150.00), in June 22, 2002 we sent correspondence to your office explaining our circumstances along with a check for \$150.00 and a copy of the annual business report dated 2001.

We did all of the above and we waited until this past Friday to call to find out that our papers were rejected due to our messages detailing our needs were lost?

As you notice we have been fighting over this issue near a year, I'm appealing to you to wave any late or other type of penalty fees assessed to our entity.

I'm attaching a check for \$ 300.00 dollars, which pays for the 2001 and 2002 annual business report.

I'm extremely confident this correspondence can finally lie to rest this burden.
