## ARTICLES OF INCORPORATION

OF

## ALLBOSS, INC.

The undersigned Incorporator of these Articles of Incorporation is a natural person competent to contract and hereby forms a corporation for profit under the General Corporation Act and other laws of the State of Florida.

#### ARTICLE I. NAME AND PRINCIPAL OFFICE

The name of this corporation is AllBoss, Inc. and its principal office is located at 100 Boardwalk Drive #815, Ponte Vedra Beach, Florida 32082.

ARTICLE II. DURATION

This corporation is to exist perpetually.

ARTICLE III. PURPOSE
