ARTICLE I - NAME

The name of this corporation shall be: FOUR KINGS AUTO TRANSPORT, INC.

ARTICLE II - PRINCIPAL PLACE OF BUSINESS

The principal place of business of this corporation shall be:

ARTICLE III - DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.




