The address of the initial registered and principal office of this Corporation is 13337 S.W. 46th Lane , Miami Florida 33175 .


The Board of Directors may from time to time designate such other address and place for the registered or principal office of this Corporation as it dems fit .


ARTICLE VIII - INCORPORATOR

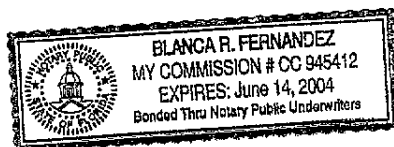
