Enclosed are the 2001 Uniform Business Report and the \$150.00 fee for BLS Ventures, Inc., document number P00000098008. In addition, I am writing to request for an exception to the late filing fee.

One day near the end of last April I was running errands. One of these errands included a trip to the post office to drop off the mail, including our UBR. Unfortunately, I was involved in a car accident, a head on collision actually, and was taken to the hospital by ambulance. Luckily, I was all right, but pretty badly banged up and on bed rest for several days afterward. In the meantime, GEICO, my auto insurer went to the garage where my car was towed, assessed the vehicle, than called me to tell me it was beyond repair. We decided I would bring him title to the car and they would give me a check in return. The car was taken to the salvage yard, and the mail, including the UBR was never retrieved. All in all, things were pretty confusing, as the accident was a real shock.

Not long afterward, we received notice that our UBR was late, and when I backtracked to figure out why this was, it all traced back to the day of my accident.

Please. I am requesting an exception to this \$400.00 late fee because it was truly a result of this unfortunate incident that our report was late. This is the first year in which we are filing a report, and the late fee is very expensive. The penalty seems very severe giving the circumstances surrounding why my report never reached your offices. Thank you for your consideration. If need be, I can forward you documentation surrounding the accident, but I will need to request this from my insurer. *(There is one piece of documentation attached, but more can be provided).*
