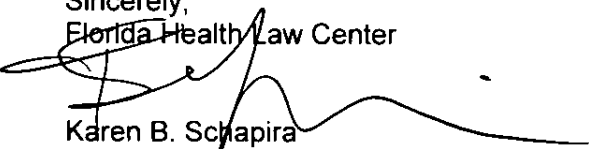
This firm represents The Broward Heart Group, PA ("BHG") as its general counsel. Enclosed is an Amended Annual Report for 2008. Effective August 1, 2008, BHG consists of four (4) corporate officers. The Amended Annual Report shows the deletion of two (2) officers, the addition of two (2) officers, and the change of address for the remaining two (2) officers.

As we discussed earlier today, the Florida Department of State, Division of Corporations ("Division") failed to accurately modify the information regarding BHG as of 2003. Enclosed is the 2003 Annual Report which clearly designates ten (10) corporate officers. These ten (10) individuals were admitted to the company in 2003 pursuant to the terms and conditions stipulated in the corporate Bylaws and in accordance with Florida Statutes. The 2004 Annual Report does not reflect the changes implemented in 2003. While I understand that the system only displays six (6) corporate officers at any given time, the remaining four (4) should have been reflected in a PDF addendum. This scribe's error is having a significant negative impact on BHG because the Worker's Compensation laws require all exempt officers to be listed on the Division's website.

This firm maintains corporate records which reflect the veracity of the information contained in this letter. Upon request, I can provide you with any supporting documentation needed. Please correct the record to reflect ten (10) officers from 2003 through July 31, 2008. Also, please amend the record so it reflects that effective August 1, 2008, only those four (4) officers designated in the enclosed Amended Annual Report as the corporate officers of BHG.
