Articles of Incorporation.

The undersigned, is the subscriber to these Articles of Incorporation, under the provisions of 607 F.S. Florida General Corporation Act.

ARTICLE I
NAME AND ADDRESS

The name of the corporation is: Dentistry at Mainlands, Inc., The physical address of the corporation is 9371 US Highway 19 North #A, Pinellas Park, Florida 33782.

ARTICLE II
DURATION

This corporation shall exist perpetually, commencing on the date of the Incorporator execution of these articles which has been delivered to the Secretary of State of Florida within five days of acceptance and filing of these Articles by the Secretary of State of the State of Florida.

ARTICLE III
PURPOSE OF BUSINESS

The purpose of this corporation is to engage in any activity of businesses permitted under the laws of the United States of America and of the State of Florida.

ARTICLE IV
CAPITAL STOCK

This right is waived by any holder of the common stock who does not exercise it and pay for the stock available for purchase pursuant to such preemptive rights, within thirty days of his receipt of a written notice from this corporation stating the price, terms and conditions of the issue of shares and inviting him or her to exercise his preemptive rights.

These Articles of Incorporation may be amended in the manner provided by law and the Bylaws of this Corporation.

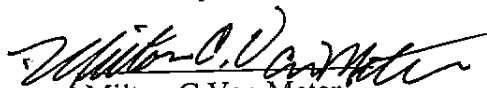
ARTICLE XIII
