

ARTICLES OF INCORPORATION OF FAMILY LIFE CARE, INC.

The undersigned subscribers certify that we have associated ourselves together for the purpose of forming a corporation for profit under the laws of the State of Florida, providing for the formation, rights, privileges, and immunities of corporations for profit.

ARTICLE I CORPORATE NAME

The name of the corporation shall be FAMILY LIFE CARE, INC.

ARTICLE II PRINCIPAL ADDRESS
