ARTICLES OF INCORPORATION

OF

ARTICLE I - NAME

The name of this Corporation is HIGHGRADE CLEANING SERVICES, INC. initial address: P.O. Box 941201, Maitland, Florida 32794-1201.

ARTICLE II - DURATION

This Corporation shall have perpetual existence commencing on October 11, 2000.
