ARTICLES OF INCORPORATION OF

By these Articles of Incorporation, the undersigned Subscriber forms a professional service corporation in accordance with Chapter 607, <u>Florida Statutes</u>, and pursuant to the following provisions ("Articles"):

ARTICLE I

NAME

The name of the corporation shall be Synergy Health & Fitness Studio, Inc., and, for convenience, shall be referred to in this instrument as the "Corporation".

ARTICLE II

DURATION

The Corporation shall exist perpetually unless and until dissolved according to law. Corporate existence of the Corporation shall commence upon the filing of these Articles with the Florida Department of State.
