The name of the Corporation is Inside Out Home & Garden Center, Inc.

The date when corporate existence shall commence shall be the date of the filing of these Articles of Incorporation in the Office of the Florida Department of State, and the Corporation shall have perpetual existence thereafter.

ARTICLE III

The Corporation is organized to engage in the business of selling home and garden accessories and supplies and to perform any and all other lawful business activities.


ARTICLE IX


