PURSUANT to the provisions of Section 607.187 of the Florida Statutes, the undersigned corporation adopts the following Articles of Amendments to its Articles of Incorporation:

1. Until this amendment, the name of the corporation was:

EARTHSEARCH OF FLORIDA, CORP.

2. The following amendment to the Articles of Incorporation was adopted by the Stockholders of the Corporation on May 21, 2001, in the manner prescribed by the Florida General Act:

THE NAME OF THE CORPORATION IS CHANGED TO:

EARTH IMMIGRATION ON LINE, INC.

3. The number of shares of the Corporation outstanding at the time of such adoption was ONE HUNDRED MILLION (100,000,000), and the number of shares entitled to vote thereon was ONE HUNDRED MILLION (100,000,000).
4. The number of shares voted for such amendment was ONE HUNDRED MILLION (100,000,000), which represents all the shares outstanding at this time. The amendment does not provide for an exchange, reclassification or

cancellation of issued shares and does not provide for a change in the amount of stated capital.

5. The date of the adoption of the amendment was: May 21, 2001.

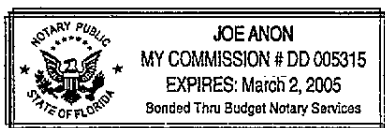
