AMENDMENT



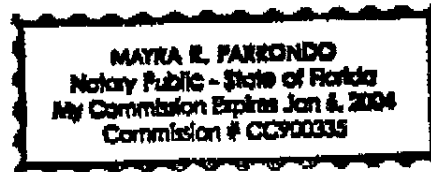
